What will I learn in Junior Lifeguard?

- First Aid
- CPR
- Basic Lifequard Skills
- Spinal Injuries on land and in the water
- Basic Swim Instructor Skills

What should I bring to Training?

- A positive and professional attitude
- A swim suit (one piece for girls)
- Water bottle and snacks
- Sack Lunch—food can be microwaved if needed
- Notebook for taking notes/ doing projects

What else do I need to know?

- This course requires a lot of swimming! Your child needs to be proficient in swimming to be fully prepared for this class.
- Financial assistance is available.
- Those who complete Junior Lifeguard Training and pass CPR and First Aid (part of the course) may have the opportunity to volunteer as a Junior Lifeguard during open swim hours, camp swim, swim lessons, or at other times of day. If a certified JR Lifeguard volunteers at least 100 hours at the YMCA they will get the Lifeguard class for half the price!
